# MISSION VALLEY WOMEN'S GOLF ASSOCIATION

## 9-HOLE LEAGUE BYLAWS

### *Article I - Name*

The name of this Association is the Mission Valley Women's Golf Association (MVWGA) 9-Hole League.

### *Article II - Purpose*

The purpose of the Association is to enjoy golf in the camaraderie of others. Our goal is to improve our game both in skill and knowledge by engaging in weekly and special competitive events from the Fall through the Spring.

### *Article III - Membership*

Membership in this Association is open to all classifications of members as determined by the Mission Valley Country Club (MVGCC) Board of Directors.

Annual dues are voted on by the Association membership at the Spring general meeting if a change is requested. Dues are payable by October 31 for renewing members or at the day of joining Mission Valley for new members.

Membership is valid for new and seasonal members.

### *Article IV - Meetings*

General meetings will be held in the Fall, Mid-Winter and Spring. Election and installation of the Officers are held during the Spring general meeting. A quorum for a general meeting is not less than twenty-five (25%) of the attending membership. Other meetings are held at the President's discretion. Special meetings of the Association, Executive Committee, Board of Directors, and committees may be called by the President.

A meeting of the Board of Directors will be held as necessary.

### *Article V - Officers*

The elective officers ("Officers") of the Association are President, Vice President, Treasurer, and Secretary.

The Officers compose the Executive Committee. The Executive Committee is responsible for general supervision of the affairs of the Board of Directors between Board meetings, makes recommendations to the Board of Directors, and performs such duties as specified in these Bylaws. Any action of the Executive Committee will be reported in full at the next Board of Directors meeting. A quorum of the Executive Committee consists of two (2) members.

### *Article VI - Duties of Officers President*

Serves as Chief Executive Officer of Mission Valley Women's Golf Association (MVWGA) 9 Hole League and as *ex officio* member of all committees.

Presides at all meetings of the Association.

Selects Executive Committee member to serve as representative of the MVWGA 9 Hole League on the Mission Valley Membership Committee, Greens Committee and Golf Committee.

Appoints new Officers if positions become vacant during her term of office with the approval of the remaining members of the Executive Committee.

Reviews the budget with the Treasurer.

Disburses and deposits funds of the Association under the direction of the Executive Committee in the absence of the

Treasurer.

Creates the calendar of events for the coming season with the assistance of the Vice President.

Appoints a Nominating Committee Chairperson in January and posts the names of the committee members on the bulletin board.

Appoints ad hoc committee chairpersons as needed.

Reports any action taken by the Executive Committee and/or the Board of Directors to the Membership at the next meeting.

Presents any proposed changes in annual dues to the membership for a vote at the Spring general meeting.

Notifies all appropriate MVGCC staff and committees of newly elected executive members.

Maintains a folder in the traveling document box for the history of the year. It shall include the minutes, the budget, and information on special events such as the Invitational. She may appoint a historian to assist with the task.

### *Vice President*

Assumes the duties of the President in her absence

If the office of President becomes vacant, she assumes the duties of the President for the remainder of the unexpired term and is eligible for election as President for the coming season

Assists the President to create the calendar of events for the coming season and submits the list for publishing in the WGA Handbook.

Serves as Chairperson for any special event that calls for a separate entry fee to participate.

Creates and maintains the bulletin board with the assistance of the board secretary.

### *Secretary*

Records minutes of all the Association's general meetings and post those meeting minutes on the Association bulletin board.

Performs the duties of the President and Vice President in their absence.

Tracks weekly winners to identify those achieving emeritus status. Keep the Pro Shop apprised of the current emeritus status of the membership, so they award weekly prizes accurately.

Assists with annual Handbook updates.

Orders name badges for new members.

Assists the Vice President in keeping the Association bulletin board up to date including the posting of weekly sign-up sheets and preparing other notices as needed.

### *Treasurer*

Verifies dues and fees collected by the MVGCC administrative office on behalf of MVWGA 9 Hole League.

Monitors the MVWGA9 Hole League monthly invoice statement provided by the MVGCC administrative office, keeps accurate records of the finances, obtains receipts, and directs the disbursement of funds as approved by the Board of

Directors or Executive Committee.

Presents a written financial report to the Board of Directors as needed, and to the membership at all general meetings.

Prepares an annual proposed budget in consultation with the President for the Association for the fiscal year and presents it to the Executive Committee for approval.

Prepares proposed budgets for special events in consultation with the Vice President and presents it to the Executive Committee for approval.

#### *Article VII - Election of Executive Committee*

Election and installation of the Executive Committee is during the Spring general meeting. Election is by ballot. If there is only one (1) candidate for an office, election may be by voice vote. Election is by majority vote of members present.

#### *Article VIII - Terms of Service for Executive Committee*

Executive Committee members are elected to serve two (2) consecutive years. The Vice President assumes the office of the President upon completion of her term/terms unless she has exhibited a dereliction of duties or is unable to serve as President.

Elected members assume their responsibility immediately after the election except for the Treasurer who will assume her duties no later than July 1.

#### *Article IX - Board of Directors*

The Board of Directors is composed of the Officers and chairpersons of the committees approved each year by the President. The quorum of the Board of Directors will be 2/3 of the total number of both these groups.

The Board of Directors:

- Reviews changes to the Bylaws and general policy as recommended by the Executive Committee.

- The Board of Directors will meet in person, or virtually prior to general meetings as needed, and requested by the President.

- Approves the yearly calendar of events, the prize money amounts, the fees for special events and the amount of annual dues and other issues as presented by the Executive Committee.

#### *Article X - Nominating Committee*

The President appoints a Chairperson for the Nominating Committee in January with the approval of the Executive Committee. The Committee is composed of a chairperson and two (2) members.

One member is from the Executive Committee and two (2) from the general membership all appointed by the Nominating chairperson. The names of the committee members are posted on the bulletin board by the President.

The Nominating Chairperson presents the names of the proposed slate of Officers to the membership by posting them on the Association bulletin board at least two (2) weeks prior to the Spring general meeting.

A slate of nominees for all Executive Committee positions is presented to the Membership at the Spring General Meeting for a vote.

#### *Article XI - Committees*

Each year the President will identify the list of committees needed for the upcoming year. These committees will be announced at the Spring general meeting. The President appoints chairpersons for each committee. The chairpersons are responsible to the Executive Committee and become part of the Board of Directors of the Association.

The Vice President is the chairperson for any special event that is identified for that year.

Each chairperson appoints the number of members she deems necessary to serve on the committee. Each chairperson will be asked to provide an update of their committee's activity at any Board of Directors meeting.

#### *Article XIII - Parliamentary Authority*

The rules contained in the current edition of Robert's Rules of Order Newly Revised govern the Association in all cases to which they are applicable and in which they are not inconsistent with these Bylaws.

#### *Article XIV - Amendments to the Bylaws*

These Bylaws may be amended at any General Meeting of the Association by a two- third (2/3) vote of those present and voting, provided the amendment has been posted on the Association bulletin board (15) days prior to the Meeting.
